2 **Preamble**

3 1. Affirming our belief in God, we still hold these truths to be self-evident, that all men are created equal,  
4 that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty,  
5 and the Pursuit of Happiness. Throughout the world, people dare to dream of freedom and opportunity.  
6 The Republican Party of Texas unequivocally defends that dream. We strive to preserve the freedom  
7 given to us by God, implemented by our Founding Fathers, and embodied in the Constitution. We  
8 recognize that the traditional family is the strength of our nation. It is our solemn duty to protect innocent  
9 life and develop responsible citizens. We understand that our economic success depends upon free  
10 market principles. If we fail to maintain our sovereignty, we risk losing the freedom to live these ideals.

11 **Principles**

12 2. We, the 2020 Republican Party of Texas, believe in this platform and expect our elected leaders to  
13 uphold these truths through acknowledgment and action. We believe in:

- 14 3. 1) "The laws of nature and nature's God," and we support the strict adherence to the original  
15 language and intent of the Declaration of Independence and the Constitutions of the United States  
16 and of Texas.
- 17 4. 2) The sanctity of innocent human life, created in the image of God, which should be equally  
18 protected from fertilization to natural death.
- 19 5. 3) Preserving American and Texas sovereignty and freedom.
- 20 6. 4) Limiting government power to those items enumerated in the United States and Texas  
21 Constitutions.
- 22 7. 5) Personal accountability and responsibility.
- 23 8. 6) Self-sufficient families, founded on the traditional marriage of a natural man and a natural  
24 woman.
- 25 9. 7) Having an educated population, with parents having the freedom of choice for the education of  
26 their children.
- 27 10. 8) The inalienable right of all people to defend themselves and their property.
- 28 11. 9) A free enterprise society unencumbered by government interference or subsidies.
- 29 12. 10) Honoring all of those that serve and protect our freedom.

31 **Business, Commerce and Transportation**

32  
33 13. Utilities: We encourage free-market solutions for providing utilities whenever possible.

34  
35  
36 14. Power Grid: We urge that the Texas Legislature pass legislation to harden the Texas Electric Grid  
37 against:

- 38 1. Cyberattacks on the grid’s computerized command and control system.  
39 2. Physical attacks on substations and major high voltage transformers.  
40 3. Geomagnetic storms created by solar flares from the sun.  
41 4. Electromagnetic Pulse (EMP).

42

43

44 **15. Smart Meters:** We support a no-cost smart meter opt-out for all utility customers in Texas.

45

46

47 **16. Insurance Rates:** We support that all types of insurance rates, for example: health, life, title, auto, and  
48 homeowner’s insurance, should be set through free-market forces.

51 **17. Intrastate Commerce:** We believe that goods and services that are not transported across state lines  
52 are not subject to federal regulations.

53

54

55 **18. Municipal Preemption:** We encourage the Legislature to preempt local government efforts to interfere  
56 with the State’s sovereignty over business, employees, and property rights. This includes but is not limited  
57 to burdensome regulations on short-term rentals, bags, sick leave, trees, and employee criminal  
58 screening. We support preemption of city ordinances that dictate sick leave policies to private businesses.  
59 This excludes the handling of emergency orders.

60

61

62 **19. Carbon Tax:** We oppose all efforts to classify carbon dioxide as a pollutant. We further urge the US  
63 Senate to defeat the “Cap-and-Trade” legislation, as it is outside the authority of the US Constitution.

64

65

66 **20. Energy Production:** We support free-market solutions and immediate removal of government barriers  
67 and direct subsidies to the production, reformulation, refining, and distribution of energy.

68

69

70 **21. Environment:** We oppose environmentalism that obstructs legitimate business interests and private  
71 property use, including the regulatory taking of property by governmental agencies. We oppose the abuse  
72 of the Endangered Species Act to confiscate and limit the use of personal property and infringement on a  
73 property owner’s livelihood. We support the defunding of “climate justice” initiatives, the abolition of the  
74 Environmental Protection Agency, and repeal of the Endangered Species Act.

75

76

77 **22. Ethanol:** We support the repeal of legislation mandating ethanol as a fuel additive.

78

79

80 **23. Government Accountability:** We call upon the Texas Legislature to eliminate all special collective  
81 bargaining statutes for public employees and to hold all public servants accountable to taxpayers through  
82 existing civil statutes. We oppose any distribution of taxpayer dollars to unions.

83

84

85 **24. Windstorm Association:** We urge the Texas Legislature to phase out the Texas Windstorm Insurance  
86 Association to reduce the liabilities it imposes on state taxpayers.

87

88

89 **25. Licensing:** We call upon the Texas Legislature to review all business/professional licensing programs  
90 and associated licensing for boards for the purpose of abolishing as many as reasonably possible and  
91 repealing those laws, rules, and regulations.

92

93

94 **26. Minimum Wage:** We believe the Minimum Wage Act should be repealed.

95

96

97 **27. Prevailing Wage:** We oppose prevailing wage laws.

98

99

100 **28. Practice Law:** We support allowing any person to sit for the Texas State Bar Exam regardless of  
101 where he or she received their law education, as long as criminal and ethical background requirements  
102 are met.

103

104

105 **29. Blue Laws:** We urge the Texas Legislature to eliminate antiquated "Blue Laws."

106

107

108 **30. Dodd-Frank:** We support the immediate repeal of Dodd-Frank legislation.

109

110

111 **31. Sarbanes-Oxley:** In light of the high compliance costs imposed by the Sarbanes-Oxley regulations  
112 and the destructive effects this law has had on innovation and capital formation, we support repeal of the  
113 Sarbanes-Oxley legislation.

114

115

116 **32. Doxing:** We recommend the State Legislature consider modifying existing state law to take into  
117 account the implications of doxing that results in harm to one's person or business.

118

119

120 **33. Regulating the Internet:** We oppose all efforts to further regulate the internet in the United States or  
121 internationally.

122

123

124 **34. Social Media Freedom:** The Republican Party of Texas calls on our Congressional Delegation to  
125 push for reform of Section 230 of the Communications Decency Act to limit the ability of Online Social  
126 media platforms to censor the speech of citizens in the new digital town square which they currently  
127 control.

128

129

130 **35. Retirement Accounts:** We support the repeal of the required minimum disbursement from retirement  
131 accounts and inheritances.

132

133

134 **36. Social Security Opt-Out:** We support reform to Social Security that allows people to opt out.

135

136

137 **37. Rural and Volunteer Fire Departments:** We urge Congress to overturn the rules of the United States  
138 Department of Labor restricting volunteerism by paid firefighters and emergency medical technician  
139 personnel and support protections similar to those provided to National Guardsmen for service during  
140 declared emergencies.

141

142

143 **38. Small Business:** We urge the federal and state legislatures to reduce regulations on small businesses  
144 and home-based work.

145

146

147 **39. Trade Agreements:** We support free trade as a necessary component of American capitalism and of  
148 the United States' influence in the world. We strongly oppose the Trans-Atlantic Trade and Investment  
149 Partnership (TTIP) and the Trade in Services Agreement (TISA). We demand the immediate withdrawal  
150 from the Central American Free Trade Agreement (CAFTA). We demand the repeal of the current Fast  
151 Track Authority/TPA.

152

153

154 **40. Vehicle Inspection:** No non-commercial vehicles should be required to obtain a state safety  
155 inspection.

156

157

158 **41. Vehicle Registration:** Vehicle registration should only be a one-time occurrence at the point of sale.

159

160

161 **42. Flooding Mitigation, Hurricane, and Early Warning of Impending Disaster:** We support the immediate  
162 study, implementation, and construction of projects that will:

163

1. Address river, bayou, reservoir, and other flood threats to public and private property.

164

2. Seek the input of those most likely to be affected by a casualty to public and private property, to  
include infrastructure and facilities that affect national security.

165

166

3. Address the risk of storm or tidal surge that affects the critical industries along the Gulf Coast.

167

4. Create an early warning system that will immediately alert residents to an impending flood, wind,  
or casualty weather event.

168

169

5. Establish regional Flood Control Districts where necessary for counties to resolve joint flooding  
issues.

170

171

6. Provide funds to complete these projects from federal, state, and local funds, to include  
specifically targeted taxes for the purpose and never for any other purpose.

172

173 We strongly urge that the Republican Party of Texas make this a legislative priority. Governments at all  
174 levels must work together to avoid the historical bent to push projects, safety, and implementation into the  
175 future. Projects must be of most urgent priority now in order to avoid further trauma; loss of life; loss of  
176 personal, government, and business wealth; and diminution of the tax base.

177

178

179 **43. Regulatory Burden:** We support action by the Texas Legislature clarifying existing state law without  
180 attaching new taxes or fees to the fantasy sports industry, which would grow the size and scope of  
181 government.

182

183

184 **44. Open Markets:** We urge the Texas Legislature to adopt legislation eliminating the mandatory three-  
185 tier system of production, distribution, and retail. Texans should have the freedom to purchase and service  
186 products (e.g. alcohol, vehicles, and medical supplies) directly from manufacturers, just as any other retail

187 product.

188

189

190 **45. Toll Roads:** We believe that tolls should come off the road when the debt is retired, and if the debt is  
191 ever restructured or refinanced, the pay-off date needs to remain the same or receive voter approval in  
192 order to extend the toll tax longer. Maintenance should then revert to the Texas Department of  
193 Transportation (TxDOT).

194 Public-private partnerships, toll authorities, and construction:

- 195 a. We oppose public-private partnerships, specifically regarding toll projects.  
196 b. We oppose conversion of existing roads or lanes to toll roads.  
197 c. We oppose the use of taxpayer money to subsidize, guarantee, prop up, or bail out any toll  
198 projects, whether public or private, and we call upon both state and federal lawmakers to  
199 adequately fund our highways without hidden taxes, tolls, or raiding emergency funds.

200 Toll administration and collections:

- 201 a. We urge the legislature to pass a uniform toll collection and billing procedure that prohibits  
202 excessive fines and fees along with other pro-taxpayer reforms such as requiring agencies  
203 to:  
204 i. send out accurate bills for actual road usage in a timely manner without tacking on  
205 additional fines and fees.  
206 ii. immediately notify drivers if a payment card is not working prior to tacking on fines  
207 and fees for non-payment.  
208 iii. calculate any fines and fees based on a monthly billing cycle not on a per  
209 transaction basis.  
210 iv. allow for a longer period of time before being placed into collections.  
211 v. allow payment plans to be set-up prior to being put into collections.  
212 b. We call upon the legislature to pass legislation to decriminalize the failure to pay tolls. We  
213 also call upon the legislature to remove the ability of toll agencies to block drivers' vehicle  
214 registrations and to impound cars based on unpaid tolls.  
215

216

217 **46. Tidelands and Resources:** We demand that the State of Texas and all coastal states enjoy and  
218 maintain jurisdiction and control of their offshore waters up to the international water boundaries as well as  
219 state inland waterways in regards to all natural resources therein, and that the federal government shall  
220 not set limits on harvesting or taking natural resources therein, nor allow foreign entities to harvest or take  
221 such natural resources therein, including minerals, game, fisheries, and hydrocarbons. Also, we demand  
222 that no entity shall usurp Texas's original tideland boundaries.

223

224

225 **47. Water Resources:** While we support the decision by the Texas Supreme Court in preserving  
226 individuals' rights to their groundwater under their property and their right to capture it, we support tying  
227 surface rights of ownership to groundwater rights of ownership. We support regulations that may put limits  
228 on a person's capture and use of groundwater if such use will negatively impact adjoining owners' use of  
229 their groundwater for private wells, their water supply, or agricultural use.

230

231

232 **48. The Lacey Act:** The Republican Party of Texas condemns the over-criminalization of trade in plants  
233 and animals under the Lacey Act and supports the RELIEF legislation.

234

235

236 **49. Origin Labeling:** We urge that all food products entering the United States not only show the country  
237 of origin, but also the country which processed it and the country that packaged it.

238

239

240 **50. Lower Taxes:** We support no taxes across the board.

241

242

243 **51. Freedom Food:** We urge no legislation be passed to restrict purchase of edible products such as  
244 meat, milk, eggs, vegetables, etc. directly from small farms and any regulations prohibiting that be  
245 rescinded.

246

247

248 **52. Predatory Towing:** We urge the Texas Legislature to enact legislation increasing the criminal  
249 penalties resulting from predatory towing and decreasing the state allowed amount that a tower can  
250 charge to disincentivize the practice of predatory towing.

251

252

253 **53. Employee Stock Ownership Plans (ESOPs):** Republicans support maximum economic opportunity for  
254 all citizens and believe that legal limits on employee ownership of Texas firms by Employee Stock  
255 Ownership Plan (ESOP) trusts should be eliminated. We also believe that changes in ownership from  
256 private individuals to a majority Ownership by an ESOP should not create a disadvantage when doing  
257 business with the State of Texas or political subdivisions of the State. We believe the State of Texas  
258 should encourage the creation of more ESOP's by making information easily available to businesses  
259 located in Texas.

260

261

262 **54. Municipal permitting:** We call on the Texas Legislature to continue to streamline the building  
263 permitting process to ease burdens and cost on developers and consumers. We encourage the  
264 Legislature to monitor implementation of existing legislation that protects property development rights and  
265 close loopholes that cities are using to circumvent these laws. We oppose retroactive rulemaking and  
266 changing the rules on developments that have already been issued permits.

267

268

269 **55. High Speed Rail:** Taxpayer money should not fund or subsidize high speed rail.

270

271

272 **56. COVID-19 Liability:** Businesses are not held liable for any customer who frequents their business and  
273 later is confirmed to test positive for COVID-19.

274

275

276 **57. Jobs Are Essential:** We urge the Texas State Legislature to adopt legislation which recognizes and  
277 establishes all businesses and jobs as essential and a fundamental right.

278

279

280 **58. Mask Mandates:** Government should not be able to force businesses to require face coverings.

281

282

283 **59. Vehicle Titles:** We call upon the Texas Legislature to direct the department of motor vehicles to  
284 immediately reinstate all home, kit, or cottage industry vehicle titles that have been revoked since the  
285 creation of that agency in 2009, and prohibit this agency from further revocation of titles.

286

287

288 **60. Unions:** We support legislation requiring labor unions to obtain consent of the union member before  
289 that member's dues can be used for political purposes. We oppose card check. Texas should prohibit  
290 governmental entities from collecting dues for labor unions through deductions from public employee  
291 paychecks. We also encourage the adoption of a National Right to Work Act.

292

293

## 294 **Constitutional Issues**

295

296 **61. The Rights of a Sovereign People:** The Republican Party of Texas supports the historic concept,  
297 established by our nation's founders, of limited civil government jurisdiction under the natural laws of  
298 God, and we oppose the concept that the state is sovereign over the affairs of men, the family, and the  
299 church. We believe that government properly exists by the consent of the governed and must be  
300 restrained from intruding into the freedoms of its citizens. The function of government is not to grant  
301 rights, but to protect the unalienable, God-given rights of life, liberty, property, and the pursuit of  
302 happiness of all, including the unborn.

303

304

305 **62. Right to Free Speech:** We resolve that free speech shall remain free; that opinions may be spoken,  
306 recorded, printed, published and shared without censorship or reprisal and that Congress will ensure that  
307 individuals rights to free speech will not be infringed upon with unconstitutional laws defining "hate  
308 speech" and "hate crimes." Texans should be free to express their religious beliefs, including prayer, in

309 public places.

310 The Republican Party of Texas calls for the reinforcement of protections regarding online speech on all  
311 Internet-based platforms and strongly urges the federal government to enforce existing free speech  
312 protections regarding the designation of platforms that practice censorship of political speech as  
313 publishers with the appropriate legal liability such as pursuant to section 230 of the Communications  
314 Decency Act of 1996.

315

316

317 **63. Keep Oath to the Constitution:** The Republican Party of Texas calls for all who swear the oath to  
318 support and maintain the limitations and clear meaning of the United States Constitution.

319

320

321 **64. Preservation of our Constitutional Republic:** We support our constitutional republican form of  
322 government as set forth in the Texas Bill of Rights. We oppose initiative and referendum. We oppose  
323 socialism, communism, fascism, and/or Marxism or any other form of tyranny in any form. We support the  
324 Texas Legislature and the United States Congress in enacting legislation that prohibits any judicial  
325 jurisdiction from allowing any substitute or parallel system of law, which is not in accordance with the  
326 United States or Texas Constitutions. We further resolve that all amendments to the Texas Constitution  
327 require a majority of the voters in at least 191 counties (three-fourths), instead of a simple majority of the  
328 votes.

329

330

331 **65. State Sovereignty:** Pursuant to Article 1 Section 1 of the Texas Constitution, the federal government  
332 has impaired our right of local self-government. Therefore, federally mandated legislation that infringes  
333 upon the 18th Amendment rights of Texas, should be ignored, opposed, refused, and nullified. Texas  
334 retains the right to secede from the United States should a future president and congress change our  
335 political system from a constitutional republic to any other system.

336

337 **66. No Foreign Law:** No foreign law (including Sharia law) or international edict shall preempt the United  
338 States Constitution or the Texas Constitution, or be used as the basis for any decision, except required  
339 by contract between individual private parties.

340

341

342 **67. Judicial Overreach:** All attempts by the judiciary to rule in areas not constitutionally granted to the  
343 judiciary including abuses of the "commerce clause," the "general welfare clause," and the "supremacy  
344 clause," should be nullified. Any federal enforcement activities that do occur in Texas should be  
345 conducted under the authority of the county sheriff. (SCOTUS Ruling in 1997 Mack-Prinz vs. US)

346

347

348 **68. Limiting the Power of the Supreme Court:** Judges don't define the role of judges, Article III, Section 2  
349 define the roles of judges. We support Congress limiting the power of the Supreme Court by invoking  
350 Article 3, Sec. 2, Clause 2 by "legislating exceptions and creating regulations" to limit the cases for which  
351 the Supreme Court has jurisdiction.

352

353

354 **69. National Popular Vote:** The national popular vote, interstate compact, is a direct violation of Article 1,  
355 Section 10 and Article 2, Section 1 of the Constitution and shall be rejected by Texas and all its officials.  
356 We support the electoral college.

357

358

359 **70. Recall Elections:** We support the right to recall our elected officials.

360

361

362 **71. State Electoral College:** Be it resolved that the state legislature shall cause to be enacted a State  
363 Constitutional Amendment creating an electoral college consisting of electors selected by the popular  
364 votes cast within each individual state senatorial district, who shall then elect all statewide office holders.

365

366

367 **72. Habeas Corpus:** We oppose any bill or provision that would suspend habeas corpus for American  
368 citizens, except as addressed by the US Constitution.

369

370

371 **73. US Citizenship:** We support a change to the 14<sup>th</sup> amendment to eliminate "birth tourism" or anchor  
372 babies by granting citizenship only to those with at least one biological parent who is a US citizen.

373

374

375 **74. Census:** In accordance with Article I Section 2 of the United States Constitution, we support an actual  
376 count of United States citizens only, and we oppose Census Bureau estimates and the collection of all  
377 other data.

378

379

380 **75. United States Senators:** We support restoring state sovereignty with the repeal of the 17th  
381 Amendment of the United States Constitution and the appointment of United States Senators by the state  
382 legislatures.

383

384

385 **76. Term Limits:** We support term limits of twelve years for federal and state offices.

386

387

388 **77. National Language:** We support a constitutional amendment making English the official language of  
389 the United States, and one of no more than two official languages of all US territories and other  
390 possessions.

391

392

393 **78. Executive Orders:** We oppose all executive orders, whether by a president, a governor, or a local  
394 official, that go beyond administration of executive authority and have the effect of legislation. We call  
395 upon the president to rescind the executive order allowing unionization of collective bargaining by any or  
396 all federal employees.

397

398

399 **79. Affirmative Action:** We believe in equal opportunity for all citizens without regard to race or gender.  
400 We believe in Martin Luther King's dream of a colorblind society.

401

402

403 **80. Family Values:** We support the affirmation of traditional Judeo-Christian family values and oppose the  
404 continued assault on those values.

405

406

407 **81. National Sovereignty:** Any agreement or treaty entered into by the US with any foreign government or  
408 international entity, such as a non-governmental organization, that is not ratified in accordance with the  
409 constitution by the US Senate is void and unenforceable.

410

411

412 **82. Right to Self-Defense:** We affirm that lawful gun ownership and carry by the people protects us from  
413 those who wish to do harm and guards against tyranny by our own government. We call upon gun  
414 owners of Texas to regulate themselves through exercising safe handling procedures, voluntarily  
415 receiving training and helping others to train others, and safely carrying firearms as a deterrent to crime.  
416 We support all legislation and policies that reduce restrictions on legal gun owners age 18 and over to  
417 purchase, own, or carry any type of gun, ammunition, accessory, knife, or other weapons, and oppose all  
418 legislation and policies that hinder the same.

419

420

421 **83. Restore Firearms Freedom:** We support the following state legislation: Constitutional Carry, allowing  
422 law-abiding citizens who are not prohibited from possessing handguns to carry them openly or concealed,  
423 while maintaining the option of a permit for reciprocity purposes; an Intrastate Protection Act, exempting  
424 guns made and sold in Texas from federal regulations and preventing Texas from enforcing federal law  
425 not also affirmed. We support National Reciprocity for handgun carry.

426

427

428 **84. Gun Carry and Possession Restrictions:** We oppose any measure that would deprive someone of  
429 their right to possess firearms without being convicted of a crime or found mentally incompetent by a  
430 medical psychiatric professional, or that would cause gun owners to be investigated by law enforcement  
431 or appear before a judge when there is no reasonable cause of a crime committed. This includes state  
432 legislation such as red flag laws, social media monitoring that targets gun owners, expanded background  
433 checks, mandates on personal firearms storage, and government-mandated location restrictions such as  
434 those in K-12 schools and 51% establishments; and Federal law such as PTSD-related restrictions and  
435 the National Firearms Act.

436

437

438 **85. Amend Texas Constitution:** We call for the Texas Legislature to propose to the people of Texas a  
439 constitutional amendment to strike the following words from Article I Section 23 of the Texas Constitution:  
440 “but the Legislature shall have power, by law, to regulate the wearing of arms, with a view to prevent  
441 crime.”

442

443

444 **86. Unfunded Mandates:** Unfunded mandates are unacceptable. The state of Texas must fully fund at a  
445 minimum the following additional costs to local governments:

- 446 • Indigent criminal defense
- 447 • Inmate health care in jails
- 448 • Indigent burials and autopsies
- 449 • Veteran services offices

450

451

452 **87. War Powers:** Congress shall not abdicate the war powers to the executive branch except when under  
453 imminent threat and not to be used as a preemptive strike unless approved by Congress.

454

455

456 **88. Lockdowns Never Again:** The Republican Party of Texas calls upon our elected officials to never  
457 again implement mass lockdowns on the people, our businesses and churches in the name of  
458 communicable disease response; nor should Texas officials ever again presume they know better how to

459 treat or prioritize the medical treatment of Texans and to make command and control edicts that dictate to  
460 health care providers how to do their job. We oppose funding or implementation of any form of contact  
461 tracing.

462

463

464 **89. Protecting Constitutional Rights Regarding Age:** Be it resolved that the Republican Party opposes all  
465 efforts to deny rights and privileges to adult citizens based solely on their age. We further state that all  
466 rights and duties of citizenship which are granted based on age, including but not limited to: voting,  
467 involuntary military service, signing legal contracts, owning or possessing firearms, consenting to medical  
468 treatment, being charged as an adult with a crime, using alcohol or tobacco, getting married and paying  
469 income taxes should be conferred when a citizen is an adult at the same age, whatever that age may be.  
470 Conferring the duties of citizenship at one age while conferring the privileges of citizenship at a different  
471 age is an unconstitutional practice in violation of the 14<sup>th</sup> amendment.

472

473

474 **90. Limit Executive Power:** In the event the Executive Branch activates the emergency powers for a  
475 disaster, the Legislature will automatically be convened two weeks later for a session to take up whatever  
476 matters deemed necessary for the Legislature.

477

478

## 479 **Criminal and Civil Justice**

480

481 **91. Parents' Rights:** We support legislation ensuring that the parents' rights to raise and educate their  
482 children are protected in Texas law as a fundamental, constitutional right and that there is a presumption  
483 that fit parents act in the best interest of their children.

484

485

486 **92. Equal Parenting:** We support legislation providing for equal and consistent parenting (possession and  
487 access) for every child. When both parents are fit, willing, and able as it is in the best interest of the child.

488

489

490 **93. CPS:** We call for the eventual abolishment of CPS, and in the interim we support reform and any  
491 legislation that would support due process in family court proceedings, oversight of the system, and a jury  
492 determining the outcome of any case if requested by either party.

493

494

495 **94. Abortion Homicide Exemption:** The physician homicide exemption of the Texas Penal Code Section  
496 19.06 should be modified to apply only to non-elective abortions such as required to save the life of the  
497 mother.

498

499

500 **95. Capital Punishment:** Properly applied capital punishment is legitimate and should be reasonably swift  
501 while respecting all due process.

502

503

504 **96. No Arrest for Non-jailable Offenses:** We call upon the Texas Legislature to end the practice of  
505 arresting individuals for offenses for which jail is not an allowable consequence under the law.

506

507

508 **97. Police, Firefighters, and Other First Responders Appreciation:** We express our gratitude and  
509 appreciation for police officers, firefighters, and other first responders. We support them in the exercise of  
510 their duties. To that end we support proper funding for robust training programs that provide them with  
511 intensive and comprehensive physical and academic training in the classroom and on the ground. We  
512 also support funding of proper mental health care and encouragement for officers.

513

514

515 **98. Written or Recorded Consent:** We call upon the Texas Legislature to require officers to get written or  
516 recorded consent (i.e., body cams) to conduct a search and inform motorists that they can decline such  
517 consent if the search is not based on probable cause or arrest.

518

519

520 **99. Mental Health Support Backup:** We support trained mental health personnel backup being provided  
521 to peace officers at all hours day and night in order to serve the public.

522

523

524 **100. Protection from Arbitrary Stops:** Texas Legislature is to enact legislation to protect Texans from  
525 arbitrary stops, detentions or arrests for only openly carrying a firearm.

526

527

528 **101. Obscenity Exemption:** We urge repeal of the Texas Penal Code “Obscenity Exemption” [43.24(c)],  
529 which allows children access to harmful, explicit, or pornographic materials under the guise of education  
530 materials.

531

532

533 **102. Civil Asset Forfeiture:** We call upon the Texas Legislature to abolish civil asset forfeiture and to  
534 ensure private property only be forfeited upon a criminal conviction.

535

536

537 **103. Victims of Human Trafficking:** We call upon the Texas Legislature to amend the Code of Criminal  
538 Procedure to allow victims of human trafficking to have convictions within the previous five years for  
539 prostitution offenses set aside, if they received these convictions as a direct result of being trafficked.

540

541

542 **104. Human Trafficking Jurisdiction:** The Texas Legislature should pass legislation granting the Texas  
543 Attorney General full concurrent jurisdiction over multi-jurisdictional cases to be limited specifically to  
544 those cases involving human trafficking.

545

546

547 **105. Government Surveillance:** We oppose all forms of warrantless government surveillance of United  
548 States citizens and businesses.

549

550

551 **106. Location and Data Privacy:** We call upon the Texas Legislature to protect citizens' current and  
552 historic technologically available location data by requiring a warrant based on probable cause for  
553 governments to request access, except in the case of an immediate, life-threatening situation. We also  
554 call on the Texas Legislature to require appropriate policies regarding the disclosure of data collection  
555 when no criminal case is filed.

556

557

558 **107. Hate Crimes:** We urge the complete repeal of the hate crimes laws, since ample laws are currently  
559 in effect to punish criminal behavior towards other persons.

560

561

562 **108. Right to See Charge:** Defendants charged with violating a governmental regulation should have the  
563 right to see the enabling law.

564

565

566 **109. Indefinite Detention:** We oppose the indefinite detention of United States citizens without due  
567 process. We urge our government to terminate detention without due process, including, but not limited  
568 to, any military enforcement of federal law within the State of Texas, under NDAA Sections 1021 and  
569 1022.

570

571

572 **110. Juries:** We support the right to privacy and security of prospective jurors. Courts must show  
573 relevance in questioning jurors and balance the prospective juror's right to privacy and lawyers' need to  
574 know. We support the right to inform the jurors of their common law power to judge law (jury nullification),  
575 as well as the evidence, and to vote on the verdict according to their conscience.

576

577

578 **111. Frivolous Lawsuits:** We support further reform to discourage frivolous lawsuits. We oppose the  
579 abusive use of class action lawsuits.

580

581

582 **112. Marriage Officiation:** We believe religious institutions have the freedom to recognize and perform  
583 only those marriages that are consistent with their doctrine.

584

585

586 **113. Law Enforcement Equipment:** We call upon the Texas Legislature to implement reporting and  
587 training standards to disclose how much military-grade material is sent to local law enforcement under the  
588 Department of Defense's 1033 program and ensure that it is being used appropriately, and to require the  
589 local governing authority over a police force to approve, by vote, an application or grant request prior to  
590 the request being made to a federal agency.

591

592

593 **114. Raise the Age:** We call upon the Legislature to raise the age of criminal responsibility from 17 to 18  
594 years.

595

596

597 **115. Warrant Validity:** The filers of search warrants should be held responsible for the validity of the  
598 information used to obtain the warrants.

599

600

601 **116. Bail Reform:** We call upon the Texas Legislature to ensure bail in Texas is based only on a  
602 person's danger to society and risk of flight, not on the person's ability to pay.

603

604

605 **117. Pandemic Release:** The Republican Party Texas opposes the release of convicted felons from  
606 prison due to a risk of infection within the prison system during a pandemic.

607

608

609 **118. Pandemic Business Fines:** The RPT supports prohibiting fines or imprisonment of business owners  
610 for operating their business during pandemics and call for the legislature to pass these protections into  
611 law.

612

613

614 **119. Political Policing:** We believe that laws should be enforced uniformly, that punishment should meet  
615 the crime, and that law enforcement should never be used to target individuals for political purposes.

616

617

618 **120. Police Brutality:** The Republican Party of Texas opposes police brutality.

619

620

621 **121. Fraudulent Lien Filings:** We support legislation designed to reduce fraud by requiring that the  
622 identity of the debtor on all liens be confirmed prior to filing by at least three methods, including but not  
623 necessarily limited to state ID, county records, and personal contact.

624

625

626 **122. Police Unions:** The Texas Legislature should ban collective bargaining with police unions.

627

628

629 **123. No-Knock Raids:** Republican Party of Texas calls upon the Texas Legislature to greatly limit the  
630 use of no-knock raids.

631

632

633 **124. Oppose Riots:** We oppose riots, vandalism, and looting and condemn such conduct as domestic  
634 terrorism. We advocate that each and every said criminal act be dealt with immediate arrest,  
635 imprisonment, and prosecution, to the fullest extent of the law.

636

637

638 **125. Independent Review:** Be it resolved that in every incident involving the death of a citizen which was  
639 directly caused by a law enforcement officer that the family of the deceased should be given the right to  
640 have an independent review convened within a reasonable time and that relatives of the deceased should  
641 be allowed to present evidence pertinent to the incident.

642

643

## 644 **Education**

645

646 **126. Local Control for Education:** We believe that all children should have access to quality education.  
647 Under the US Constitution, the power to regulate education is reserved exclusively to the States and to  
648 the people. Parents have the primary right and responsibility to educate their children. The classroom  
649 should be a place where all viewpoints are welcomed, free speech is celebrated, and “person before  
650 politics” beliefs are preached. We support the right of parents to freely choose public, charter, private,  
651 parochial, or homeschooling for their children. We support the right of parents to choose the specific  
652 public school that their children attend. No child should be forced to attend a failing school. We reject the  
653 imposition of federal education standards and the tying of any government funding to the adoption of  
654 federal education standards. We reject the intrusion of government in private, parochial, or homeschools.  
655 We affirm that the policies, procedures, activities, and finances of public education in Texas at all levels  
656 should be fully transparent. To ensure transparency, the check register of all traditional school districts

657 and charter schools should be posted online with the link on the home page. We respect parental  
658 authority regarding sex education. We believe that abortion providers and affiliates should be prohibited  
659 from providing any curriculum or instruction in schools.

660

661

662 **127. Abolish Department of Education:** Since education is not an enumerated power of the federal  
663 government, we believe the Department of Education should be abolished, and prohibit the transfer of  
664 any of its functions to any other federal agency.

665

666

667 **128. Eliminate the Harris County Department of Education:** Because Harris County Department of  
668 Education is the only county department of education remaining in Texas after Independent School  
669 Districts were created to fulfill the role, the Harris County Department of Education must be eliminated,  
670 along with its taxing authority. All assets of the Harris County Department of Education would be  
671 distributed equitably to the Independent School Districts within the county.

672

673

674 **129. Campus Speech:** We urge the Texas Legislature to recognize the rights of those on college  
675 campuses to practice their faith and their right to free speech. We further urge that the Texas Legislature  
676 write legislation to protect the right of students, faculty, and invited guests/speakers. We support  
677 withdrawal of public funding from any college or university within this state that actively or passively  
678 discriminates or permits discrimination against the free speech of either students or guest speakers.  
679 Student groups shall have the unfettered right to elect their leaders, choose their members, and set their  
680 organization's mission, purpose, and standard of conduct.

681

682

683 **130. Religious Freedom and Public Schools:** We urge school administrators and officials not to infringe  
684 on Texas school students' and staffs' rights to pray and engage in religious speech, individually or in  
685 groups, on school property without government interference. We urge the Legislature to end censorship  
686 of discussion of religion in our founding documents and encourage discussing those documents,  
687 including the Bible as their basis. Students have the right to exhibit religious items on school property.

688

689

690 **131. Special Treatment:** Our state universities and public schools shall not make special concessions  
691 based on religious practices that create undue burdens and costs for the institution.

692

693

694 **132. Basic Standards:** The educational system should focus on basic standards which include, but are

695 not limited to, a curriculum of reading (with an emphasis on phonics), spelling, writing, civics (must pass  
696 the US Citizenship and Immigration Services test) the arts, music, literature, mathematics (including  
697 personal finance), science, geography, economics, and United States and world history. We encourage  
698 teaching critical thinking skills, including logic, rhetoric, and analytical sciences within these subjects. We  
699 advocate the value of vocational training programs.

700

701

702 **133. Founding Documents in High School:** We support a high school level curriculum (rather than 8<sup>th</sup>  
703 grade level) for the study of American history (pre-1877) that are heavily weighted toward the study of  
704 original founding documents, including the Declaration of Independence, the United States Constitution,  
705 the Constitutional Convention, and Founders' writings.

706

707

708 **134. Scientific Theories:** We support objective teaching of scientific theories, such as life origins and  
709 climate change. These shall be taught as challengeable scientific theories subject to change as new data  
710 is produced. Teachers and students shall discuss the strengths and weaknesses of these theories openly  
711 without fear of retribution or discrimination of any kind.

712

713

714 **135. National Core Curriculum:** We oppose the use of national or international standards in the State of  
715 Texas (i.e., Common Core, TEKS Resource System (formerly CSCOPE), United Nations Inclusion,  
716 National Sexuality Education Standards, and SIECUS, etc.) We also oppose the modification of college  
717 entrance exams to reflect any national core philosophies. Any school district that violates state law  
718 banning the use of a national core curriculum or standards shall lose all state funding until said curricula  
719 or standards are removed and no longer utilized in classrooms.

720

721

722 **136. American Identity:** We favor strengthening our common American identity, which includes the  
723 contribution and assimilation of diverse racial and ethnic groups. We reject Critical Race Theory as a  
724 post-Marxist ideology that seeks to undermine the system of law and order itself and reduce individuals to  
725 their group identity alone. We support legislation to remove this ideology from government program,  
726 including education involving race, discrimination, and racial awareness. To facilitate the appreciation of  
727 the contrast of the tyrannical history of socialism/communism throughout history must be taught. Students  
728 shall pledge allegiance to the United States and Texas flags daily to instill patriotism. Students have the  
729 right to display patriotic items on school property. Schools should have the options to display the National  
730 Motto "In God We Trust."

731

732

733 **137. Bilingual Education:** We encourage non-English-speaking students to transition, via best practices,  
734 to English within two years, allowing them to quickly assimilate and succeed in American society.

735

736

737 **138. Elected SBOE:** We believe that the SBOE should continue to be an elected body consisting of  
738 fifteen members. Their responsibilities must include:

- 739 1. Appointing the Commissioner of Education.  
740 2. Maintaining constitutional authority over the Permanent School Fund.  
741 3. Maintaining sole authority over all curricula content.  
742 4. The state adoption of all educational materials. This process must include public hearings.

743 The SBOE should be minimally staffed out of general revenue.

744

745

746 **139. School Options:** Texas families should be empowered to choose from public, private, charter, or  
747 homeschool options for their children’s education, using tax credits or exemptions without government  
748 restraints or intrusion.

749

750

751 **140. School Security:** The Texas Legislature shall pass a statute that allows LTC (License to Carry)  
752 holders to carry a concealed firearm on the premises of Pre K-12 schools for security and protection  
753 purposes.

754

755 **141. Textbook Approval:** The Texas Education Code (TEC) must be amended to empower the State  
756 Board of Education (SBOE) to require each school district that adopts non-state-approved instructional  
757 materials to conform to the SBOE higher approval process to protect citizens’ right to petition, correct  
758 factual errors, prevent corruption, and fulfill legislative intent in the TEC. Local school district boards must  
759 hold public hearings prior to adoption on such materials, and citizens should have access to review  
760 classroom materials upon request at any time.

761

762

763 **142. Oversight of Instructional Materials:** All instructional materials paid for with state funds should be  
764 vetted by the elected State Board of Education, and we oppose appropriation of state funds for  
765 instructional content that has not been approved by the SBOE. We call for the repeal of the lobby-driven  
766 Senate Bill 6 (82nd Legislature, 1st Called Session), which allows Common Core-based materials and  
767 liberal propaganda into the classroom.

768

769

770 **143. Sexual Education:** We demand the State Legislature pass a law prohibiting the teaching of sex  
771 education, sexual health, or sexual choice, or identity in any public school in any grade whatsoever, or  
772 disseminating or permitting the dissemination by any party of any material regarding the same. All school  
773 districts, individual schools, or charter schools are prohibited from contracting with or making any

774 payment to any third party for material concerning any of the above topics. Until this prohibition goes into  
775 effect, sexual education shall only utilize sexual risk avoidance programs and promote abstinence outside  
776 of marriage. Before a student may be provided with human sexuality or family planning instruction, the  
777 district must obtain the written consent of the student's parent or guardian [Opt-In status].

778

779

780 **144. Gender Identity:** The official position of the Texas schools shall be that there are only two genders:  
781 biological male and biological female. We oppose transgender normalizing curriculum and pronoun use.

782

783

784 **145. Inappropriate Content:** We request that the Texas Legislature pass legislation that requires Texas  
785 schools and libraries to filter inappropriate content, such as pornography, for minors. Operators of adult  
786 sex entertainment businesses and venues, adult entertainment of any kind, including Drag Queen Story  
787 Hour, shall not be part of educational programming in public schools, libraries or any other taxpayer  
788 funded program for children.

789

790

791 **146. Fair Play for Texas Athletes:** We hold that biological men shall compete against other biological  
792 men and biological women shall compete against other biological women in athletics in the public school  
793 system of Texas and at the collegiate level.

794

795 **147. Healthcare in Public Schools:** Legislators shall prohibit reproductive healthcare services, including  
796 counseling, referrals, and distribution of condoms and contraception through public schools. We support  
797 parents' right to choose, without penalty, which medications are administered to their minor children. We  
798 support informed consent of parents before any school based mental health assessment or interventions  
799 are performed.

800

801 **148. School Health Advisory Councils:** Until the legislature removes sex education from the curriculum  
802 of public schools, the State of Texas should adopt changes to Texas Education Code 28.004 to require  
803 every member of the School Health Advisory Council (SHAC) to be appointed by the Board of Trustees;  
804 require at least 50% of SHAC be parents of students within the district: require at least 50% of the parent  
805 attendees be present for business to be conducted and require every school district to post SHAC  
806 meeting minutes, full and fair disclosure of the contents of the human sexuality instruction, and proposed  
807 changes to health education; close loopholes and prohibit contraception distribution and demonstration;  
808 and expand the grievance process to cover the entire section of Texas Education Code 28.004.

809

810

811 **149. Foreign Charter Schools:** Charter schools should have accountability and transparency to local  
812 parents, taxpayers, and the State of Texas, as do current public schools, including United States

813 citizenship of public school trustees. We oppose public funding of charter schools that receive money  
814 from foreign entities. We urge the Texas Legislature to enact legislation that requires charter school  
815 operators to be American citizens.

816

817

818 **150. Supporting Military Families in Education:** We ask for truancy waivers for the students whose  
819 parents are being deployed for up to 5 days prior to their departure, and up to 5 days for those returning  
820 from deployment. We support the waiver of out-of-state tuition for any dependent of military personnel  
821 stationed in Texas.

822

823

824 **151. Due Process for Teachers:** Teachers should be afforded the opportunity of due process.

825

826

827 **152. Tenure:** We support abolishing the system of tenure in academia and advocate replacing it with a  
828 merit-based system for teacher retention.

829

830

831 **153. College Tuition:** We call upon the Texas Legislature to take reasonable measures to curtail tuition  
832 increases. The Legislature should pass a law clearing the way for all Texas public universities to adopt at  
833 least one applied major through the "Affordable Baccalaureate Program."

834

835

836 **154. Equal Access:** All Texas students shall have equal access to all state-supported grants,  
837 scholarships, and loans, based upon measurable academic criteria. Illegal aliens shall not be eligible for  
838 state or federal grants or financial assistance. We support the suspension of federal funding from  
839 universities that prohibit military recruitment on campus. We support Texas college admissions based  
840 solely on merit.

841

842

843 **155. Texas School Reopenings:** If Texas schools are unable to reopen on the regularly scheduled  
844 school calendar for in-person instruction, the taxpayers should not be forced to pay for it as this puts an  
845 undue burden on Texas families.

846

847

848 **156. No Pass No Play:** School districts performing below state education standards shall be restricted

849 from issuing bond debt for the construction or renovation of sports facilities.

850

851

## 852 **Finance**

### 853 (Spending Restraint)

854

855 **157. Government Spending and Taxation:** We in the Republican Party of Texas believe in the principles  
856 of constitutionally limited government based on federalist principles. To this end, we encourage our  
857 elected officials at all levels of government to work to reverse the current trend of expanding government  
858 and the growing tax and debt burdens that places on “We the People.” Government spending is out of  
859 control at the federal, state, and local levels, and action is needed.

860

861

862 **158. Federal Fiscal Restraint:** We urge Congress to become more fiscally responsible by immediately  
863 enacting the following items:

- 864 1. Adopt zero-based budgeting.
- 865 2. Adopt a policy of requiring a private sector efficiency commission for each governmental  
866 department.
- 867 3. Oppose the use of “earmarks” as a part of the budget and spending process.
- 868 4. Prohibit Congress from passing appropriations bills unless each appropriations group is  
869 considered and passed separately.

870

871

872 **159. State Fiscal Restraint:** Amend the Texas Constitution and state statute with a stricter spending  
873 limitation based on US Census population growth plus inflation as measured by the Consumer Price  
874 Index and apply the new limit to Texas’s total government budget.

875

876

877 **160. Local Fiscal Restraint:** We support local government efficiency and believe that cities and counties  
878 of a certain size could benefit from a third-party, objective review of their budgets and operations. We call  
879 on the Texas Legislature to prompt the utilization of third-party efficiency audits to identify opportunities  
880 for improvement and streamline operations.

881

882

883 **161. Entitlement Reform:** We support federal entitlement reform for welfare, Social Security, and  
884 Medicare to protect these programs for future generations. We oppose taxation of Social Security

885 benefits.

886

887

888 **162. Economic Stabilization Fund:** We oppose the use of the Economic Stabilization Fund (Rainy Day  
889 Fund) to expand government. Use of the Economic Stabilization Fund should be limited to its intended  
890 purposes of preventing tax increases during economic downturns and responding to unforeseen  
891 disasters.

892

893

894 **163. Government Pensions:** The Texas Legislature shall enact new rules to begin to transition  
895 government pensions for ERS and TDCRS members from a defined benefit pension to a defined  
896 contribution retirement plan similar to a 403(b).

897

898

899 **164. Gambling:** We oppose the expansion of legalized gambling. We oppose and call for a veto of any  
900 budget that relies on expansion of legalized gambling as a method of finance.

901

902

903 **165. Line-Item Veto:** We support strengthening the line-item veto authority of the Governor.

904

905

906 **166. Veto Session:** We support a constitutional amendment permitting the Legislature to return for a  
907 three-day session in response to the Governor's veto.

908

909

910 **167. State Income Tax Ban:** We support maintaining the current ban on state income taxes in Texas.

911

912

913 **168. Truth in Taxation:** We urge that taxes established for a particular purpose shall not be used for any  
914 other purpose.

915

916

917 **169. Public Posting:** We support all government entities compiling and publicly posting their current  
918 debt, future obligations, financial statements, check registers, and all government contracts on their  
919 official websites.

920

921

922 **170. Transportation and Fuel Taxes:** We resolve that tax revenue derived from gasoline taxes and all  
923 other taxes/fees on our vehicles (including vehicle sales tax) should only be used for road construction  
924 and maintenance, and not be diverted to any other use, including mass transit, rail, restrictive lanes, and  
925 bicycle paths.

926

927

928 **171. Death Tax:** Abolish the Estate Tax (commonly known as the Death Tax).

929

930

931 **172. Higher Education Spending Control:** State Higher Education appropriations, grants, and loans  
932 should not subsidize or encourage tuition increases or growth in administrative cost.

933

934

935 (School Finance and Property Taxation)

936

937 **173. Defund Big Government, Not the Police:** Any large city or county that cuts its police budget by  
938 more than 20 percent should be required to cut its property tax revenue by the same or greater  
939 percentage.

940

941

942 **174. Management Districts:** We oppose the creation of management or special purpose districts with the  
943 authority to impose taxes and bonded debt, and we oppose the use of eminent domain by these districts.

944

945

946 **175. Permanent School Fund:** We support saving the Permanent School Fund for future generations  
947 and oppose raiding it or using it as a source of additional funding for the state budget. We oppose any  
948 effort to remove State Board of Education authority over the Fund, whose constitutionally intended  
949 purpose is to fund SBOE-approved instructional materials.

950

951

952 **176. Abolish Property Tax:** We support replacing the property tax system with an alternative other than  
953 the income tax and requiring voter approval to increase the overall tax burden. We urge the legislation to  
954 develop a transition plan that is a net tax cut (one of the solutions could be a consumption tax).

955

956

957 **177. Property Tax Increase Limitation:** We support the legislation that limited property tax revenue  
958 increases to 2.5 percent for school maintenance and operations and 3.5 percent for most other units of  
959 government. We call on the Legislature to close the disaster loophole in this bill. We call on the legislature  
960 to require taxing authorities to make taxpayers whole when property taxes were raised more than 3.5  
961 percent without voter approval.

962

963

964 **178. Homestead Appraisals:** We support allowing homeowners to contest their homestead appraisals in  
965 Justice of the Peace court.

966

967

968 **179. School Finance:** We support a simple, fair, and efficient method for financing our public school  
969 system. We oppose the “Robin Hood” system of public school finance and believe the Texas Legislature,  
970 not the courts, should determine the amount of money spent on public education and the distribution  
971 thereof. We oppose the Edgewood I and II decisions that legislate school finance from the bench.

972

973

974 **180. Administrative Bloat Is Not Transformative:** We call on Texas school administrators to deliver more  
975 education for our dollars, instead of nonstop lobbying for more dollars for education. At a minimum, 55  
976 percent of revenue should be spent in the classroom. We oppose the underhanded strategy of making  
977 cuts to visible front-line teaching positions instead of administrators and overhead.

978

979

980 **181. School Maintenance and Operation Property Tax:** We call upon the Texas Legislature to use  
981 surplus revenue to buy down the school maintenance and operation property tax rate as a prelude to  
982 replacing it with a broader based consumption tax.

983

984

985 **182. Tax Notice for Renters:** We support requiring appraisal districts to publish the amount of property  
986 taxes and appraisals attributable to each rental unit. We support exploring cost-effective ways to notify  
987 renters how much property taxes they pay via rent.

988

989

990 (Opposition to Market-Distorting Tax and Fiscal Subsidies)

991

992 **183. School Property Tax Abatements:** We support repealing Tax Code Chapter 313 school property

993 tax abatements.

994

995

996 **184. Bailouts and Subsidies:** We encourage government to divest its ownership of all businesses that  
997 should be run in the private sector, and allow the free market to prevail; this includes all businesses run  
998 by school boards and Texas Educational Service Centers. We oppose all bailouts of domestic and foreign  
999 government entities, states, and all businesses, public and private.

1000

1001

1002 **185. Community Reinvestment Act:** We support the repeal of the Community Reinvestment Act.

1003

1004

1005 **186. Lending Institutions:** We support the sale of the federal government's interest in Federal National  
1006 Mortgage Association (Fannie Mae) and Federal Home Loan Mortgage Corporation (Freddie Mac) and  
1007 SLM Corporation [Sallie Mae Corp].

1008

1009

1010 **187. Special Funds:** We urge the Texas Legislature to abolish the Special Events Trust Fund program,  
1011 the Texas Enterprise Fund, and the Moving Image Industry Incentive Program.

1012

1013

1014 **188. Pro Stadiums:** Tax dollars should not be used to fund the building of stadiums for professional or  
1015 semi-professional sports teams.

1016

1017

1018 **189. Public Broadcasting:** We oppose tax dollars for the Corporation for Public Broadcasting.

1019

1020

1021 **190. Audit the Fed:** We support additional accountability and transparency for the Federal Reserve  
1022 System including regular performance audits.

1023

## 1025 **Government and Foreign Affairs**

1026

1027 (Government Operations)

1028

1029 **191. Cybersecurity Voter Registration:** The State of Texas should use any undedicated federal election  
1030 funds received to improve the security of our online voter registration data.

1031

1032

1033 **192. Elected Appraisal Boards:** We believe appraisal district boards should consist entirely of elected  
1034 officials in the geographically affected area.

1035

1036

1037 **193. Sexual Harassment:** The Republican Party of Texas believes sexual harassment should not be  
1038 tolerated. Persons in a position of responsibility should conduct themselves in a family-friendly manner.

1039

1040

1041 **194. Government Authority:** We believe any government authority that has the ability to levy a tax or fee  
1042 on the people should be accountable to those who pay the taxes via the electoral process, from the local  
1043 level to the federal level.

1044

1045

1046 **195. Federal Land in Texas:** All federal land in Texas should be returned to and administered by Texas,  
1047 except for land specifically authorized in the Constitution (military bases, federal buildings, post offices).

1048

1049

1050 **196. Tax-Funded Lobbying:** We oppose using tax dollars to hire lobbyists or pay dues to associations  
1051 that lobby the Legislature.

1052

1053

1054 **197. Texas Speaker of the House:** We oppose the use of pledge cards and call for the Republican  
1055 members to caucus after each November general election to determine, by secure secret ballot, their  
1056 candidate for Speaker and Speaker Pro-Tempore. We also call for the Republican members to vote as a  
1057 unified body for their selected Speaker candidate when the Legislature convenes in regular session.

1058

1059

1060 **198. House Committees:** Texas House standing committees should advance the conservative  
1061 grassroots agenda, not that of special interests and lobbyists. The chairman and a majority of members

1062 of key committees should support the conservative agenda. Specifically, we call for a pro-life Public  
1063 Health Committee, a pro-Constitutional-Carry and pro-police Public Safety and Homeland Security  
1064 Committee, and a pro-traditional values State Affairs Committee. The Public and Higher Education  
1065 Committees should spend more time advancing conservative reforms and less time pandering to  
1066 superintendents, vendors, and university administrators.

1067

1068

1069 **199. House Calendars Committee:** We call for changes to the House Rules that require the House  
1070 Calendars Committee to vote on a bill within 14 days of receipt, or it is automatically put on calendar. We  
1071 also support automatic setting of a bill on the Calendar within seven days if it is cosponsored by three-  
1072 fifths of House members. We call for votes on each bill individually that is not set on the calendar, rather  
1073 than killing a slate of bills at once.

1074

1075

1076 **200. Candidate Support:** The Republican Party of Texas should provide financial support only to those  
1077 candidates who support the right-to-life planks.

1078

1079

1080 **201. Unelected Bureaucrats:** We oppose the appointment of unelected bureaucrats, and we support  
1081 defunding and abolishing the departments or agencies of the Internal Revenue Service; Education;  
1082 Energy; Housing and Urban Development; Commerce; Health and Human Services; Labor; Interior  
1083 (specifically, the Bureau of Land Management); Transportation Security Administration; Alcohol, Tobacco,  
1084 Firearms and Explosives; and National Labor Relations Board. In the interim, executive decisions by  
1085 departments or agencies must be reviewed and approved by Congress before taking effect.

1086

1087

1088 **202. Sunset Commission:** We support a majority citizen-led Sunset Commission.

1089

1090

1091 **203. Ordinances Providing Safe Haven Cities for the Preborn:** We support the right of Texas  
1092 municipalities to protect mothers and preborn children in their communities by passing enforceable city  
1093 ordinances that ban abortions and abortion industry businesses within their city limits.

1094

1095

1096 (Elections)

1097

1098 **204. Bond Elections:** State and local bond election ballots should be required to include the amount of  
1099 debt currently outstanding, current debt service payments, current per capita debt obligations, the amount  
1100 of new debt being proposed, estimated debt service for the new debt, and estimated per capita burden  
1101 being proposed. The bond issue must obtain a yes vote of a minimum of 20 percent of registered voters  
1102 at an election administered by the County. No public funds are to be spent influencing a bond election.  
1103 We oppose bundling of items on bond election ballots and “rolling polling” for bond and tax rate increase  
1104 elections.

1105

1106

1107 **205. Judicial Candidate Speech:** We support a state constitutional amendment that would enable  
1108 judicial candidates to express their beliefs in general terms before elections to thus inform voters of their  
1109 views.

1110

1111

1112 **206. Pay-to-Play Endorsement Slates:** We oppose “pay-to-play” endorsement slates and urge  
1113 Republican primary voters to exercise extreme caution regarding any endorsement or statement made in  
1114 these slates.

1115

1116

1117 **207. Early Voting:** We support that early voting will be limited to 7 days, ending on the Friday before  
1118 Election Day.

1119

1120

1121 **208. Fair Election Procedures:** We support the right of eligible voters to cast a ballot in each election  
1122 once but oppose illegal voting, illegal assistance, or ineligible persons registering. We support vigorous  
1123 enforcement of all our election laws as written and oppose any laws, lawsuits, and judicial decisions that  
1124 make voter fraud very difficult to deter, detect, or prosecute. We support Voter Photo ID. Internet voting  
1125 for public office and any ballot measure should be prohibited.

1126

1127

1128 **209. Ballot by Mail:** We oppose any attempt to expand the criteria for ballot by mail in Texas because of  
1129 the potential for voter fraud. We support increased scrutiny and security in balloting by mail.

1130

1131

1132 **210. Offense Enforcement for In-Person Voting:** We support raising to felony status infractions of the  
1133 Texas Election Code during in-person voting, including allowing persons not in the poll book to vote a  
1134 regular ballot, willfully misclassifying the reason for a provisional ballot, giving one voter multiple ballot  
1135 access codes or multiple ballots, and all forms of voter assistance not compliant with Texas Election

1136 Code, especially “assistants” who force themselves on voters to influence their votes.

1137

1138

1139 **211. Felon Voting:** We support the constitutional authority of state legislatures to regulate voting,  
1140 including enfranchisement of convicted felons.

1141

1142

1143 **212. Actual Residence:** We support changes to the appropriate sections of Texas law that would deny  
1144 or cancel homestead exemptions, driver licenses, and License to Carry, if the addresses on those  
1145 documents DO NOT match the address on the voter’s registration.

1146

1147

1148 **213. Consolidated Elections:** All public elections, with the exception of specially called elections, should  
1149 be consolidated to Primary and General Election days and locations.

1150

1151

1152 **214. Voter Registration:** We support restoring integrity to the voter registration rolls and reducing voter  
1153 fraud. We support repealing all motor voter laws, re-registering voters every four years, requiring photo ID  
1154 of all registrants, requiring proof of residency and citizenship along with the voter registration application,  
1155 retaining the 30-day registration deadline, and requiring that a list of certified deaths be provided to the  
1156 Secretary of State in order that the names of deceased voters be removed from the list of registered  
1157 voters. We support periodic checks on the voter rolls to ensure all currently registered voters are eligible,  
1158 with prompt removal of ineligible voters. We should give the Secretary of State enforcement authority to  
1159 ensure county registrar compliance with Secretary of State directives. We also support revising Title 19  
1160 funding to avoid incentivizing retention of ineligible voters.

1161

1162 **215. Ballot Harvesting:** We support stiff criminal penalties against so-called “ballot harvesters,” those  
1163 who collect or fill out mailed ballots on behalf of a campaign.

1164

1165

1166 **216. Campaigning at Poll Sites:** We encourage free speech at polling sites outside of the existing  
1167 boundaries. The right to campaign, including the display of signage, with respect to current state law, at  
1168 an appropriate distance (100 feet) from the polling place, shall not be infringed.

1169

1170

1171 **217. Voting Rights:** We support equal suffrage for all United States citizens of voting age. We oppose  
1172 any identification of citizens by race, origin, or creed and oppose use of any such identification for

1173 purposes of creating voting districts. We urge that the Voting Rights Act of 1965, codified and updated in  
1174 1973, be repealed and not reauthorized.

1175

1176

1177 **218. Direct Elections of State Judges:** We support our right to select our judges by direct vote.

1178

1179

1180 **219. English-Only Ballots:** English, and only English, shall appear on any ballot for any election in the  
1181 United States of America and in the State of Texas.

1182

1183

1184 **220. Closed Primary:** We support protecting the integrity of the Republican Primary Election by requiring  
1185 a closed primary system in Texas.

1186

1187

1188 **221. Crossover Voting:** We welcome people to join the Republican Party who support limited  
1189 government and traditional values. We oppose campaigns to get liberal Democrats to crossover and  
1190 move the Republican party to the left in the primary.

1191

1192

1193 **222. Redistricting:** We support drawing districts based on eligible voters, not pure population. We  
1194 believe districts should be geographically compact when possible. We oppose any redistricting map that  
1195 is unfair to conservative candidates in the primary or the general election.

1196

1197

1198 **223. County Chair Elections:** We support the election of Republican County Chairs—for counties with  
1199 more than 70,000 residents—by their respective County Executive Committees.

1200

1201

1202 (Foreign Policy)

1203

1204 **224. Council on American-Islamic Relations (CAIR):** We hereby call on all law enforcement and  
1205 governmental agencies in Texas to avoid and suspend all contact and outreach activities with the Council  
1206 on American-Islamic Relations (CAIR), named unindicted co-conspirators in the Holy Land Foundation  
1207 trial, with ties to terrorist groups such as Hamas.

1208

1209

1210 **225. Foreign Policy:** We support a foreign policy that relies on peace through the strength of our  
1211 national defense and avoids foreign deployments or entanglements. We support a free-market economy,  
1212 private humanitarian aid to developing countries, continued favorable treatment of proven allies, censure  
1213 of adversarial entities that seek destruction of other countries, and strong policy on confronting terrorists.  
1214 We strongly oppose religious or ethnic cleansing. We oppose US aid to any foreign entity that  
1215 consistently votes against our interests or is openly hostile to our nation.

1216

1217

1218 **226. Trade with China:** We support a re-examination of our trading relationship with China based on  
1219 America's economic and foreign policy interests. America should not be dependent on a communist  
1220 country for critical medical or technological resources, including prescription drugs like penicillin.

1221

1222

1223 **227. People's Republic of China Aggression:** China's aggression in South China Sea endangers  
1224 international trade routes and infringes on allied nations' sovereignty. The cybersecurity threat posed by  
1225 China continues to grow. We support the people of Hong Kong in their quest for freedom and democracy  
1226 and call for China to honor its agreements with the United Kingdom.

1227

1228

1229 **228. Foreign Aid:** We support foreign aid only to America's allies who share our values.

1230

1231

1232 **229. Iran and North Korea:** We oppose development of nuclear weapons by Iran and North Korea, and  
1233 we oppose easing sanctions on either country until their hostile behavior and nuclear proliferation cease.

1234

1235

1236 **230. Israel:** We are grateful the U.S. Embassy in Israel has been moved to Jerusalem, Israel's eternal  
1237 and indivisible capital. We strongly affirm Israel's sovereignty over the Golan Heights. We insist upon  
1238 Israel's right to exist, right to secure borders, and right to the land secured by practicing self-defense from  
1239 aggressive enemies. We oppose the creation of a Palestinian state within the historical borders of Israel,  
1240 as it would jeopardize Israel's security and it would force Israel to give up land that God gave to the  
1241 Jewish people as referenced in Genesis. We reaffirm our support for Israel maintaining a qualitative  
1242 military edge over any and all adversaries through continued support militarily, financially, and  
1243 technologically. We respect Israel's right of sovereignty, self-determination, and right of self-defense.

1244

1245

1246 **231. Oppose BDS:** We strongly oppose the anti-Semitic Boycott, Divestment, and Sanctions (BDS)  
1247 movement as a form of warfare being waged upon Israel, on all levels, including and especially on  
1248 college campuses, at the United Nations, and by anti-Western nongovernmental organizations.

1249

1250

1251 **232. Taiwan:** We call upon the United States to move toward full diplomatic recognition of Taiwan as an  
1252 independent and sovereign nation and to renew our commitment to defend our security interests in the  
1253 Western Pacific region in the face of China's military provocations, which threaten its neighbors and  
1254 critical maritime trade routes.

1255

1256

1257 **233. United Nations:** The United Nations is a detriment to the sovereignty of the United States and other  
1258 countries, and because of this we support:

- 1259 1. Our withdrawal from the current United Nations.
- 1260 2. The removal of the United Nations from United States soil.
- 1261 3. The rejection of all Agenda 21 and Agenda 2030 policies and programs.
- 1262 4. The rejection of all related NGOs, councils, and environmental programs.
- 1263 5. A zero-budget allotment of American tax dollars to any United Nations programs.
- 1264 6. The opposition of any designation of World Heritage Sites in the United States and especially in  
1265 Texas.
- 1266 7. Withdrawal from the UN Arms Trade Treaty.
- 1267 8. President Trump's withdrawal from the corrupt World Health Organization (WHO) and his  
1268 demand for reforms of that organization.
- 1269 9. A credible, impartial, and international investigation into the WHO and China's actions regarding  
1270 the COVID-19 pandemic.

1271

1272

1273 **234. UN Treaty on the Rights of Child:** We unequivocally oppose the United States Senate's ratification  
1274 of the United Nations Convention on the Rights of the Child.

1275

1276

1277 **235. Taxation by a Foreign Entity:** Any attempt to allow the United Nations or any other foreign entity to  
1278 levy taxes on United States citizens or governments should be prohibited.

1279

1280

1281 **Health and Human Services**

1282

1283 **236. Caring for Our Mentally Disabled Citizens:** We urge the Legislature to continue funding and  
1284 operating all state-supported living centers for mentally disabled legal Texas residents, and to continually  
1285 seek common sense improvements to increase efficiency.

1286

1287

1288 **237. Mental Health:** We support parents' right to choose or reject, with prior written informed consent  
1289 and without penalty, each medication and mental health assessment or survey administered to their  
1290 children.

1291

1292

1293 **238. Parental Safeguard:** We support abolishing the "Texas Child Mental Health Care Consortium," the  
1294 "trauma-informed care policy," "school-based mental health providers," "school-based or school-  
1295 connected mental health interventions," and other public school programs that serve to expand access to  
1296 minor children for development and training of thirteen university and colleges of psychiatry and their  
1297 residents.

1298

1299

1300 **239. Welfare Reform:** Welfare reform should encourage partnerships with faith-based institutions,  
1301 community, and business organizations to assist individuals in need. We encourage welfare reform in the  
1302 following areas:

1303       1. Denying benefits to individuals who cannot prove citizenship.

1304       2. Reforming welfare programs to require recipients to work, learn, and train to move toward self-  
1305       sufficiency.

1306       3. Reforming welfare programs to require recipients to remain substance-abuse free in exchange for  
1307       temporary benefits not exceeding two years.

1308       4. Requiring all welfare recipients to submit to random drug testing in order to receive benefits.

1309       5. Requiring that money provided through the Supplemental Nutrition Assistance Program (SNAP) be  
1310       used only for nutritious foods consistent with those included under the WIC program, and be  
1311       released only with a photo ID of the approved user.

1312       6. Implementing a non-monetary-based assistance program for providing supplemental food benefits.

1313       7. Removing prisoners from welfare rolls.

1314

1315

1316 **240. Federal Welfare Programs:** We support the abolition of all federal welfare programs, as they are  
1317 not an appropriate role of the federal government.

1318

1319

1320 **241. Defunding HUD's AFFH:** We support defunding HUD's Affirmatively Furthering Fair Housing  
1321 (AFFH).

1322

1323

1324 **242. Child Support Related to Welfare:** Mothers applying for government financial support, exempting  
1325 rape victims, should provide the verifiable name and any known contact information of the birth father,  
1326 which information shall be turned over to the State of Texas Attorney General's Office within 30 days for  
1327 collection of child support.

1328

1329 **243. Homosexuality:** We believe there should be no granting of special legal entitlements or creation of  
1330 special status for homosexual behavior, regardless of state of origin, and we oppose any criminal or civil  
1331 penalties against those who oppose homosexuality out of faith, conviction, or belief in traditional values.  
1332 No one should be granted special legal status based on their LGBTQ+ identification.

1333

1334 **244. Gender Identity:** We oppose all efforts to validate transgender identity. For the purpose of  
1335 attempting to affirm a person 21 or under if their perception is inconsistent with their biological sex, no  
1336 medical practitioner or provider may engage in the following practices:

- 1337 a. Intervene in any way to prevent natural progression of puberty.  
1338 b. Administer or provide opposite sex hormones.  
1339 c. Perform any surgery on healthy body parts of the under-age person.

1340

1341

1342 **245. No Taxpayer Funding for Sex Change:** We oppose the use of taxpayer funds for any type of  
1343 medical gender dysphoria treatments or sex change operations and/or treatments. This includes but is  
1344 not limited to military personnel as well as inmates in federal, state, or local prisons or jails. Inmates must  
1345 be housed according to their biological sex.

1346

1347

1348 **246. Counseling Methods:** Licensed therapists, psychologists, and counselors with the State of Texas  
1349 should not be forbidden or penalized by any licensing board for practicing Reintegrative Therapy or other  
1350 counseling methods when counseling clients of any age with gender dysphoria or unwanted same-sex  
1351 attraction.

1352

1353

1354 **247. Addiction:** We oppose legalization and decriminalization of illicit and synthetic drugs. We also  
1355 oppose any needle exchange programs. Faith-based rehabilitation programs should be considered as a  
1356 part of an overall rehabilitation program.

1357

1358

1359 **248. Healthcare Decisions:** Informed consent is a basic human right. All people have the right to weigh  
1360 the risks and benefits of any medical intervention for themselves or minor family members in determining

1361 whether or not to undergo any intervention. To this end, we declare:

- 1362 a. Healthcare decisions, including routine preventive care such as immunizations, should be  
1363 between a patient and healthcare professional and should be protected from government  
1364 intrusion.
- 1365 b. Texas public schools have a duty to inform parents they can opt out of CDC recommended  
1366 vaccinations for their children.
- 1367 c. Abortion is not healthcare.
- 1368 d. Government has no right to mandate specific medical procedures or methods of healthcare.
- 1369 e. Both the risks and benefits of a proposed intervention must be equally communicated and  
1370 accessible to the patient or to a minor patient's parents or guardian.
- 1371 f. The patient's decision, or, in the case of a minor, the parent or guardian's decision, to  
1372 undergo a procedure or not must be recognized as equally valid without bias, consequence,  
1373 or retaliation.
- 1374 g. We reject any government-mandated treatment, vaccination, or use of controlled  
1375 substances of any kind.
- 1376 h. We call for an addition to the Texas Bill of Rights that explicitly recognizes the natural right  
1377 to refuse vaccination or medical treatment and the right for such choices to not be a  
1378 condition of provision of government services.  
1379

1380

1381 **249. Texas Medical Practice Act:** To protect the rights of both patients and physicians, the Texas  
1382 Medical Board (TMB) should adopt the following provisions in the Texas Medical Practice Act:

- 1383 a. Protect the right of patients to choose natural solutions, including chiropractic care, to their  
1384 health problems, as well as the physician's right to provide natural solutions for health  
1385 problems.
- 1386 b. Eliminate confidential complaints against physicians.
- 1387 c. Eliminate anonymous medical witnesses against physicians.
- 1388 d. Mandate legal due process in all TMB proceedings.
- 1389 e. Allow physicians the right to have a complaint against them tried in a state district court,  
1390 rather than in an administrative law court.
- 1391 f. Prohibit TMB members from working for insurance, pharmaceutical companies, or hospitals  
1392 while serving on the board, to prevent conflict of interest.
- 1393 g. Prohibit intimidation tactics by TMB lawyers against physicians.  
1394

1395

1396 **250. Healthcare Choice:** No government bureaucrat or insurance company should be allowed to  
1397 interfere with citizens' freedom to choose their type of medical care. We demand the US Congress to  
1398 repeal the ACA and pass healthcare reform that results in more affordable healthcare through a market-  
1399 based, competitive, and transparent healthcare system, including but not limited to:

- 1400 a. Tort reform
- 1401 b. Interstate competition.
- 1402 c. Health savings accounts.
- 1403 d. Genuine accountability.
- 1404 e. Oversight.
- 1405 f. Portability and extended COBRA availability.
- 1406 g. Selection of coverage (rather than paying for coverage not needed or not wanted).
- 1407 h. Price transparency of all medical procedures and drugs.
- 1408 i. Medical expense sharing organizations.

1409

1410

1411 **251. Natural Medical Right:** We call for an addition to the Texas Bill of Rights that explicitly recognizes  
1412 the natural right to refuse vaccination or medical treatment and the right for vaccination or medical  
1413 treatment to not be a condition of provision of government services.

1414

1415

1416 **252. Medication Manufacturing:** Medications and prescription drugs consumed in the US should be  
1417 manufactured in the US for security, consistency, and reliability of the drug.

1418

1419

1420 **253. Water Supply:** The Republican Party of Texas opposes medication of the drinking water supply of  
1421 the state of Texas, including but not limited to fluoridation.

1422

1423

1424 **254. Cannabis Classification:** Congress should remove cannabis from the list of Schedule 1 and move  
1425 to Schedule 2. We call upon the Texas Legislature to improve the 2015 Compassionate Use Act to allow  
1426 doctors to determine the appropriate use of cannabis for their patients.

1427

1428

1429 **255. Medicaid Reform:** We support Medicaid block grants to the states and returning Medicaid to its  
1430 original purpose to be a temporary assistance. We oppose any further expansion of Medicaid.

1431

1432

1433 **256. Medicare Reform:** Medicare Part A should have a parallel opt-out to Part B for those who have  
1434 health insurance through their employer and continue to work. Part A will then kick in when they retire.

1435

1436

1437 **257. Labels on Medications:** The labels on all prescription and over-the-counter drugs, supplements,  
1438 and medical supplies must be required to show the country where manufactured or produced.

1439

1440

1441 **258. Patient Protection and Affordable Care Act (“Obamacare”):** We demand the immediate repeal of  
1442 the Patient Protection and Affordable Care Act, which we believe to be unconstitutional.

1443

1444

1445 **259. Medical Records and Informed Consent:** We oppose any state or federal medical record computer  
1446 database or that stores personal identifiable records on citizens without their written consent.

1447

1448

1449 **260. Contact Tracing:** We strongly oppose contact tracing, tracking, or surveillance, and we also  
1450 strongly oppose any action similar to the federal TRACE Act. Contract tracing, tracking, or surveillance  
1451 are not core functions of public health. No government entity, nor private entity, nor combination thereof,  
1452 nor the Texas National Guard, shall ever be employed to violate the natural rights of Texans.

1453

1454

1455 **261. Right to Try:** We urge the Texas State Legislature and Governor to enact laws that allow patients  
1456 and their doctors to have access to experimental medications and procedures that can potentially be  
1457 lifesaving or improve quality of life.

1458

1459

1460 **262. Healthcare Savings Accounts:** All individuals should be allowed to establish health savings  
1461 accounts. Individuals should be allowed higher annual contributions to health savings accounts.

1462

1463

1464 **263. Texas HSA:** We recommend the creation of the State of Texas Health Savings Account, with funds  
1465 in excess of those needed in the Rainy Day Fund, with the purpose of enabling the state to develop  
1466 reserves sufficient to exit the federal Medicaid program, which will not expire nor be utilized for any other  
1467 purpose.

1468

1469

1470 **264. Fetal Tissue Harvesting and Stem Cell Research:** We support legislation prohibiting  
1471 experimentation or commercial use of human fetal tissue, including for vaccines, which requires or is  
1472 dependent upon the destruction of human life. We encourage adult stem cell research using cells from  
1473 umbilical cords, from adults, and from any other means that does not kill human embryos. We also  
1474 support elimination of public funding for embryonic stem cell research, research on fetal tissue, or human  
1475 cloning.

1476

1477

1478 **265. Choice of Therapy:** We affirm the right of people with unwanted same-sex attraction or gender  
1479 confusion to seek therapies to meet their purposes. No laws or executive orders shall be imposed to limit

1480 or restrict access to sexual orientation change counseling, or therapy to resolve gender confusion in a  
1481 way that supports biological sex, for self-motivated youth and adults.

1482  
1483

1484 **266. Parental Rights and Responsibilities:** We support the fundamental, constitutional rights of parents  
1485 to raise and educate their children, including their rights to direct the care, custody, control, upbringing,  
1486 moral and religious training, and medical care of their children. Local, state, or federal laws, regulations,  
1487 or policies that limit parental rights in the rearing of both biological and adopted children shall not be  
1488 enacted. Parents have the God-given right and responsibility to direct and guide their children's care and  
1489 moral upbringing.

1490

1491

1492 **267. Parental Rights of Dependent Adult Children:** As long as parents are responsible for an adult child,  
1493 through college or the age of 26 when children are on the parents' insurance, the parents must have  
1494 access to medical information, grades, and other information normally afforded to parents of minor  
1495 children.

1496

1497

1498 **268. Parental Consent:** We insist on informed support parental consent for all medical care, counseling,  
1499 etc., for all minors.

1500

1501

1502 **269. Conscience Clause:** All persons and legal entities have the right of conscience and should be  
1503 protected under Texas law if they conscientiously object to participate in practices that conflict with their  
1504 moral or religious beliefs. This includes, but is not limited to, abortion, the prescription for and dispensing  
1505 of drugs with abortifacient potential, human cloning, embryonic stem cell research, eugenic screenings,  
1506 genetic engineering, euthanasia, assisted suicide, harmful futile procedures, vaccines, and the withdrawal  
1507 of nutrition and hydration.

1508

1509

1510 **270. Alternatives to Abortion:** Until abortion is made illegal in Texas, we urge the Republican Party of  
1511 Texas and the Texas Legislature to assist in educating the public regarding alternatives to abortion,  
1512 especially adoption.

1513

1514

1515 **271. Discriminatory Abortion:** We support legislation such as the "Preborn Non-Discrimination Act"  
1516 (Pre-NDA) to close existing discriminatory loopholes that fail to protect unborn children suspected of  
1517 having a "fetal anomaly" or disability and we support legislation to enact anti-discriminatory language to  
1518 apply additional protections to unborn children at risk of being aborted because of their sex, race,

1519 disability, or age of gestation, in addition to providing families with information about life-affirming social  
1520 and medical services available to them in Texas, such as perinatal palliative care.

1521

1522

1523 **272. Planned Parenthood:** We support completely eliminating public funding for Planned Parenthood  
1524 and any other abortion providers and all their affiliates, and we oppose their digital or physical presence  
1525 in our schools and other public institutions, and the expansion of their facilities in our neighborhoods.

1526

1527

1528 **273. Human Embryos:** We support the adoption of human embryos and the banning of human embryo  
1529 trafficking.

1530

1531

1532 **274. End-of-Life Patient Protection:** We support patients' rights, especially near the end of life, and call  
1533 for reform of existing legislation so that:

- 1534 1. Texas law should provide that medical personnel may not deny care, change advanced directives,  
1535 or originate directives for any patient without the permission of the patient or the patient's  
1536 designate.
- 1537 2. We also support the passage of legislation to amend the Advance Directives Act by requiring  
1538 hospitals intending or threatening to withdraw life-sustaining treatment against the patient's wishes  
1539 or their advance directive to continue all treatment and care for such patients pending transfer to  
1540 another facility.
- 1541 3. We also support legislation to prohibit the discriminatory rationing of health care services premised  
1542 on any aspect of the patient, including a patient's age, race, sex, disability, or perceived quality of  
1543 life.

1544

1545

1546 **275. Repeal and Replace Ten-Day Rule:** We support legislation repealing the unethical "Ten-Day Rule"  
1547 in Section 166.046, Health and Safety Code, which allows physicians to withdraw basic life-sustaining  
1548 treatment (like a ventilator) after an impending countdown. We also support legislation replacing the Ten-  
1549 Day Rule with a truly life-affirming law that requires a patient's or surrogate's medical decision about  
1550 basic life-sustaining treatment to be honored until the patient is transferred to another physician or facility  
1551 that will honor the decision to continue life-sustaining treatment.

1552

1553

1554 **276. Home and Community-Based Services:** We call on the Texas Legislature to support Home and  
1555 Community-Based Services (HCBS) as a pro-life alternative, and to enact language to apply additional  
1556 protections and to address any loopholes that fail to protect or provide appropriate home and community-  
1557 based alternatives for children and adults with disabilities, in addition to providing families with information  
1558 about life-affirming social and medical services available to them in Texas as alternatives to abortion and

1559 costly institutional care.

1560

1561

1562 **277. Modernized Social Security Card:** We support the improvement of our 1936 Social Security card to  
1563 use contemporary anti-counterfeit technology. The Social Security card will not be considered a national  
1564 ID card for United States citizens.

1565

1566

1567 **278. Social Security Disability:** We support appropriate limits on the length of time to receive Social  
1568 Security disability benefits for all but those truly not able to do ANY kind of paid employment.

1569

1570

1571 **279. Toxic Exposure:** We support the immediate implementation of the Toxic Exposure Research Act of  
1572 2015, which will ensure that the federal government will establish a database on all exposed veterans  
1573 and their families.

1574

1575

1576 **280. VA Medical Benefits Not Limited:** We support allowing veterans to use VA medical benefits at  
1577 private medical providers and not be limited to VA Hospitals.

1578

1579

1580 **281. Replace the VA:** We support replacing the Veterans Administration with a commercial insurance  
1581 plan that allows eligible veterans to obtain health services from any licensed provider.

1582

1583

1584 **282. Pandemic Response:** We call upon Texas elected officials to never again implement mass  
1585 lockdowns on the people of Texas in the name of communicable disease response. Texas officials shall  
1586 never again dare to presume that they know best how to medically treat Texans or prioritize the medical  
1587 treatment of Texans. Elected officials must never make command and control edicts that dictate to health  
1588 care providers how to do their job.

1589

1590

1591 **283. Pornography Crisis:** The State of Texas shall recognize that pornography is a public health crisis.

1592

1593

1594 **National Defense and Border Security**

1595

1596

1597 **284. Support of Our Armed Forces:** The men and women who wear our country's uniform, whether on  
1598 active duty or in the Reserves or National Guard, are the most important assets in our military arsenal. All  
1599 current and prior military personnel and their families must have the benefits, healthcare, housing,  
1600 education, and overall support they need. Injured military personnel deserve the best medical, mental  
1601 health, and rehabilitative care our country has to offer. Veterans Administration monetary benefits shall  
1602 match present national price index value in all programs.

1603

1604

1605 **285. Proof of Legal Residency for Public Services:** Texas shall require proof of legal residency for  
1606 obtaining a Texas driver license and enrolling in public school, and require proof of citizenship for  
1607 obtaining voter registration and public benefits.

1608

1609

1610 **286. No Gender Norming in Military:** We oppose gender norming in the military. Transgendered persons  
1611 should not serve in the military as a special class; no special considerations or medical treatment shall be  
1612 required or offered.

1613

1614

1615 **287. Missile Defense:** We urge the continuing development and enhancement of missile defense.

1616

1617

1618 **288. Military Readiness:** We support a military force of sufficient strength and readiness to deter any  
1619 threat to our national sovereignty or to the safety and freedom of our citizens. We oppose placement of  
1620 US troops under command of the United Nations.

1621

1622

1623 **289. Defeat Terrorism:** We support an aggressive war on terrorism, including radical Islamic terrorists,  
1624 which consists of cooperating with our allies and sanctioning nations that sponsor terrorists. We support  
1625 the reasonable use of profiling, the prosecution of national security breaches, and the revision of laws or  
1626 executive orders that erode our liberties. We call on the federal government to designate the Muslim  
1627 Brotherhood a foreign terrorist organization, and we call on governmental agencies to avoid and suspend  
1628 all activities with all radical Islamic organizations, such as the Council on American-Islamic Relations  
1629 (CAIR).

1630

1631

1632 **290. Abolish Refugee Resettlement Program:** We call for the abolition of the refugee resettlement  
1633 program.

1634

1635

1636 **291. Citizenship Qualification:** We call on the United States Congress to pass a constitutional  
1637 amendment that defines citizenship as those born to a citizen of the United States or through  
1638 naturalization.

1639

1640

1641 **292. Amnesty:** Any form of amnesty with regard to immigration policy should not be granted, including  
1642 the granting of legal status to persons in the country illegally. Illegal aliens shall be deported.

1643

1644

1645 **293. Border Security Funding:** We expect both the Texas Legislature and the United States Congress to  
1646 make a priority of allocating funds to effectively secure the border through whatever means necessary,  
1647 including but not limited to barriers, a border wall, and/or fence everywhere along the border where it is  
1648 feasible and useful, as well as personnel and technology over land, sea, and air.

1649

1650

1651 **294. Eliminate Illegal Immigration Magnets:** No tax dollars should be provided for social or educational  
1652 programs for illegal aliens. All existing laws providing for in-state tuition and non-emergency medical care  
1653 shall be rescinded. All non-verifiable foreign-issued identification cards shall be legally invalid in the  
1654 United States.

1655

1656

1657 **295. E-Verify:** Texas should require all employers to screen new hires through the free E-Verify system  
1658 to prevent the hiring of illegal aliens and of anyone not legally authorized to work in the US, and to protect  
1659 jobs for American workers. We call upon the 87<sup>th</sup> Texas Legislature to pass legislation to this effect.

1660

1661

1662 **296. Sanctuary Cities:** State and federal funds shall be denied to any public or private entity, including  
1663 but not limited to sanctuary cities, that are not in compliance with immigration laws. Prosecute the  
1664 responsible elected officials of Sanctuary Cities/Counties/States for obstruction of Immigration Laws.

1665

1666

1667 **297. Immigration System:** We demand that state and federal law enforcement officers enforce our  
1668 immigration laws, implement an entry/exit tracking system for visa holders, and expedite hearings on  
1669 deporting both violent and non-violent illegal immigrants and visa overstays. Chain migration and the  
1670 diversity visa lottery should be eliminated. Our legal immigration system should be strictly merit based,  
1671 and the total number of new immigrants should be limited to a level that facilitates assimilation.

1672

1673

1674 **298. H-1B Visas:** The Republican Party of Texas calls for the permanent end of the H-1B Foreign  
1675 Worker Visa program in the interest of protecting American jobs, classified technology, and national  
1676 security.

1677

1678

1679 **299. Aiding and Abetting Illegal Immigrants:** We support revoking the 501(c)3 tax exempt status of any  
1680 organization that breaks state and federal law by knowingly aiding and abetting illegal immigrants.

1681

1682

1683 **300. National Guard Deployment:** Congress shall not abdicate the war powers to the executive branch  
1684 except when under imminent threat and not to be used as a preemptive strike unless approved by  
1685 Congress. The Texas National Guard should only be deployed to overseas combat zones under  
1686 authorization of Congress through a declaration of war.

1687

1688

## 1689 **State Affairs**

1690

1691 **301. Alamo:** The Alamo is a historical event to Texas and as such:

- 1692 a. Should be remembered and not “reimagined.”
- 1693 b. Texas’s authority regarding the Alamo shall not be infringed upon by any organization or authority,  
1694 including but not limited to local governments, the federal government, the United Nations, or  
1695 UNESCO.
- 1696 c. Decision-making authority for the Alamo must never be removed from Texas.
- 1697 d. The custodians of the Alamo must be required to:
- 1698 i. Affirm and emphasize the intrinsic significance of the 1836 battle in telling the story of  
1699 the Alamo.
- 1700 ii. Maintain transparency in finances and operations of the Alamo.
- 1701 e. Specific protection shall be afforded the site, including all land and existing monuments, including  
1702 the Cenotaph, which SHALL NOT be moved from its present site.

1703

1704 **302. Heritage:** We call upon governmental entities to protect all symbols of our American and Texan  
1705 heritage and therefore:

- 1706 a. We oppose governmental action to remove the public display of the Ten Commandments or  
1707 other religious symbols.  
1708 b. We support the Pledge Protection Act. We urge that the national motto “In God We Trust”  
1709 and the National Anthem be protected from legislative and judicial attack.  
1710 c. Penalties should be established for any form of desecration of the American or Texas Flag.  
1711 d. We support preservation of Texas history and historical sites.  
1712 e. Visitors to the Alamo should conduct themselves with decorum and reverence inside the  
1713 shrine, out of respect for the sacrifice of the heroes who are honored there.  
1714 f. We call for restoration of plaques honoring the Confederate widow’s pension fund  
1715 contribution that were illegally removed from the Texas Supreme Court building.  
1716  
1717  
1718

1719 **303. Historical Monuments:** We believe all historical war memorials, including Confederate monuments,  
1720 in Texas shall be protected from future removal or defacement and that those monuments that have been  
1721 removed should be restored to their historical locations. We support the continuing allocation of funds that  
1722 are necessary to preserve the USS Texas as a permanent monument to the ship, her crew of two world  
1723 wars, and the history of the State of Texas.

1724

1725

1726 **304. Honor Our Flags:** We appreciate and honor our flags and what they represent, and we strongly  
1727 advocate for all public schools to display the US and Texas flags in every classroom and to begin each  
1728 school day with the pledges to both.

1729

1730

1731 **305. Campaign Finance Transparency:** We support laws requiring full disclosure by political candidates  
1732 of the amounts and sources of any campaign contributions, whether contributed by individuals, political  
1733 action committees, or other entities. We oppose reporting requirements that infringe on the free-speech  
1734 rights of citizens. We urge immediate repeal of all limits on campaign contributions by American citizens  
1735 to the candidates or causes of their choice.

1736

1737

1738 **306. No Restrictions on Charities:** We oppose any restrictions by any government agency on individual  
1739 taxpayer contributions to churches, faith-based charities, and other non-profit organizations.

1740

1741

1742 **307. Freedom of Assembly:** We believe in the constitutional freedom of assembly throughout Texas.

1743

1744

1745 **308. Religious Freedom for Business Owners:** We support the removal of laws and regulations that are  
1746 used to force business owners and employees to violate their conscience, sincerely held beliefs, or core

1747 values.

1748

1749

1750 **309. Public Accommodations:** We support legislation at the state and federal levels that concretely  
1751 defines public accommodations as originally defined and understood in the Civil Rights Act of 1964, that  
1752 it:

- 1753 a. Prohibit any change to that legal definition by any federal, state, or local law to expand  
1754 government control to restrict any First Amendment rights.  
1755 b. Proscribe any law that requires any private business or individual to create or provide a custom  
1756 product or service, or any kind of expressive work, or enter into a contract, or be coerced into  
1757 any speech that is not their own.  
1758

1759

1760 **310. Religious Freedom of Speech and Practice:** As America is “one nation under God,” founded on  
1761 Judeo-Christian principles, we affirm the constitutional right of all individuals to worship as they choose.  
1762 We strongly believe in Religious Freedom and Freedom of Speech. Therefore, we demand:

- 1763 a. The repeal of the Johnson Amendment, which assaults the free speech of pastors and religious  
1764 organizations.  
1765 b. Protection of the First Amendment rights of any citizen to practice their religion and exercise  
1766 their right to free speech in the public square, as well as in religious organization affiliations.  
1767 c. Elimination of Federal Internal Revenue Service (IRS) involvement with Church messaging.  
1768 d. That Texas judges and legislators uphold and defend our First Amendment rights of religious  
1769 liberty and freedom of speech, and we oppose any effort to intimidate and prevent Christians  
1770 and other people of faith from exercising their rights.  
1771 e. Acknowledgement that the Church is a God-ordained institution with a sphere of authority  
1772 separate from that of civil government, and thus the Church is not to be regulated, controlled,  
1773 or taxed by any level of civil government.  
1774  
1775

1776 **311. Daylight Saving Time:** We urge the Texas Legislature to enact legislation to end Daylight Saving  
1777 Time in Texas.

1778

1779

1780 **312. Gender Identity Facilities in Businesses:** We support enacting legislation in the State of Texas  
1781 ensuring that:

- 1782 a. No government entity in the state shall be allowed to take it upon itself to define for any private  
1783 business or private entity how it must segregate its restrooms, changing facilities, or showers.  
1784 b. Nor may any government agency be allowed to require businesses to profess, espouse, or  
1785 adopt specific views on sex, sexuality, gender, or gender identity.  
1786 c. Government agencies must guarantee that views and positions on these matters are not used  
1787 as a basis to deny access to public accommodations, as defined by the Civil Rights Act of  
1788 1964, nor to deny employment, or discriminate in employment decisions, solely on the basis of  
1789 a person’s views on these matters.  
1790

1791

1792 **313. Child Rights:** We call on the Texas Legislature to pass legislation to protect privacy in public  
1793 schools and government buildings as allowed by Title IX of the Education Amendments of 1972, by  
1794 ensuring that multi-use facilities, including showers, changing rooms, and bathrooms, are designated for  
1795 and used only by persons based on the person’s biological sex.

1796

1797

1798 **314. Gender Identity Pronouns:** We oppose any attempt to criminalize and/or penalize anyone for the  
1799 wrong use of pronouns.

1800

1801

1802 **315. Homosexual Behavior:** We affirm God’s biblical design for marriage and sexual behavior between  
1803 one biological man and one biological woman, which has proven to be the foundation for all great nations  
1804 in Western civilization. We oppose homosexual marriage, regardless of state of origin. We urge the  
1805 Texas Legislature to pass religious liberty protections for individuals, businesses, and government  
1806 officials who believe marriage is between one man and one woman. We oppose the granting of special  
1807 legal entitlements or creation of special status for LGBTQ+ behavior, regardless of state of origin. We  
1808 oppose any criminal or civil penalties against those who oppose homosexuality out of faith, conviction, or  
1809 belief in traditional values.

1810

1811

1812 **316. Definition of Marriage:** We support the definition of marriage as a God-ordained, legal, and moral  
1813 commitment only between one natural man and one natural woman.

1814

1815

1816 **317. State Authority over Marriage:** We support withholding jurisdiction from the federal courts in cases  
1817 involving family law, especially any changes in the definition of marriage.

1818

1819

1820 **318. Spousal Benefits:** We shall not recognize or grant to any unmarried person the legal rights or  
1821 status of a spouse, including granting benefits by political subdivisions.

1822

1823

1824 **319. No-Fault Divorce:** We urge the Legislature to rescind unilateral no-fault divorce laws and support  
1825 covenant marriage.

1826

1827

1828 **320. Overturn Unconstitutional Ruling:** We believe the *Obergefell v. Hodges* decision, overturning the  
1829 Texas law prohibiting same-sex marriage in Texas, has no basis in the Constitution and should be  
1830 reversed, returning jurisdiction over the definition of marriage to the states. The Governor and other  
1831 elected officials of the State of Texas should assert our Tenth Amendment right and reject the Supreme  
1832 Court ruling.

1833

1834

1835 **321. Adoption:** We encourage the Texas Legislature to remove as many barriers to adoption as possible  
1836 and make the process less intrusive while protecting children’s safety and best interests. We urge the  
1837 Texas Legislature to adopt the following steps to promote adoption:

- 1838 1. Continue to privatize the process.  
1839 2. Continue to allow faith-based agencies to set their own rules and requirements for adoptions.  
1840 3. Change incentives to encourage successful permanent placement of children instead of  
1841 continuation of foster care.  
1842 4. Remove obstacles to transracial adoptions while continuing to increase the amount of minority  
1843 adoptive parents.  
1844 5. Enact legislation to permit foster parents to initiate adoption proceedings.

1845 We urge communities and people of faith to promote adoption and for those not called to adopt  
1846 themselves to offer assistance to families that can. We believe that, in the best interests of the family and  
1847 child, the State of Texas should allow children to be adopted only by married or single heterosexuals.

1848

1849

1850 **322. Pro-life:** Until the abolition of abortion is achieved, we support laws that restrict and regulate  
1851 abortion including, but not limited to:

- 1852 a. Parental and informed consent including the elimination of judicial bypass.  
1853 b. Prohibition of licensing, liability, and malpractice insurance for abortionists and abortion  
1854 facilities.  
1855 c. Prohibition of financial kickbacks for abortion referrals.  
1856 d. Prohibition of late-term abortions.  
1857 e. Prohibition of abortions after the time an unborn child’s heartbeat is detected.  
1858 f. Prohibition of the manufacturing and sale of abortifacients.  
1859 g. Elimination of causes of action for “wrongful birth.”  
1860 h. Health insurance coverage for abortion services and abortifacients, which under Texas law  
1861 should be considered supplemental coverage and billed to the beneficiary.  
1862

1863

1864 **323. Abolish Abortion:** Since life begins at conception, we urge the Texas Legislature to abolish abortion  
1865 through enacting legislation which would immediately secure the rights to life and would ignore or refuse  
1866 to enforce any and all federal statutes, regulations, orders, and court rulings which would deny these  
1867 rights.

1868

1869

1870 **324. Dismemberment Abortion:** We strongly support the prohibition of elective dismemberment  
1871 abortions, a type of dilation and evacuation abortion, which take the life of preborn children by removing  
1872 their limbs.

1873

1874

1875 **325. State Authority over Abortion:** Consistent with plank titled Limiting the Power of the Supreme Court  
1876 in the Constitutional Issues section of this platform, we urge the Texas Congressional delegation to pass  
1877 legislation implementing their authority under Article III, Section 2 of the US Constitution to eliminate the  
1878 Supreme Court's ability to adjudicate abortion cases.

1879

1880

1881 **326. Fundamental Right to Life:** All innocent human life must be respected and safeguarded from  
1882 fertilization to natural death; therefore, the unborn, the aged, and the physically or mentally challenged  
1883 have a fundamental individual right to life, which cannot be infringed.

1884

1885

1886 **327. Reverse Roe v. Wade:** We are resolute in our support of the reversal of *Roe v. Wade*.

1887

1888

1889 **328. Property Annexation:** Homeowners and landowners in an area proposed for annexation should  
1890 have the right to vote to approve or reject the annexation, regardless of the population of the county. No  
1891 annexation can occur within 45 days of any election.

1892

1893

1894 **329. HOA Governance:** We support legislation prohibiting HOAs from using "policies" to bypass the  
1895 process of residents' voting on changes in deed restrictions We urge the Texas Legislature to enact  
1896 legislation allowing a simple majority of property owners with and subject to homeowners to dissolve the  
1897 association. The Texas Legislature should enact legislation to restrict developers from controlling the  
1898 Homeowners Association more than 5 years and expanding the properties included beyond contiguous  
1899 property.

1900

1901

1902 **330. Property Rights:** Property ownership and free enterprise, the foundation of our collective wealth,  
1903 must not be abridged nor denied by government. We support legislation to protect these bedrock rights.  
1904 Areas of concern are: annexation, eminent domain (including foreign entities), property forfeiture,  
1905 extraterritorial jurisdiction, seizure for public or private development, natural resources and conservation  
1906 easements, groundwater and/or mineral rights, nationalization of lands, and the preservation of our

1907 Fourth Amendment right to privacy. Property owners should be notified of their rights with regard to  
1908 condemnation, annexation, or easement; and the condemner should be required to petition a court of  
1909 jurisdiction to show public necessity. Taking of property should result in immediate compensation of fair  
1910 market value to the owner. These issues should be administered by elected officials accountable to  
1911 voters.

1912

1913

1914 **331. Eminent Domain:** The use of eminent domain must exclude the seizure of private property for  
1915 private economic development or increased tax revenue.

1916

1917

1918 **332. Unfunded Mandates:** We urge all governing bodies within Texas to consider the impact on  
1919 taxpayers for any mandate they pass.

1920

1921

1922 **333. Platform Integrity:** The platform committee of the Republican Party of Texas at their state  
1923 convention may not diminish the platform without a plank by plank vote.

1924

1925

1926 **334. Right to Use Cash and Cash Substitutes:** The Republican Party of Texas supports adding the  
1927 following protection to the Texas Bill of Rights: The right of the people to own, hold, and use a mutually  
1928 agreed upon medium of exchange, including cash, coin, bullion, digital currency, or scrip, when trading  
1929 and contracting for goods and services shall not be infringed. No government shall prohibit or encumber  
1930 the ownership or holding of any form or amount of money or other currency. This amendment shall not be  
1931 construed to restrain the State of Texas from choosing the mediums of exchange it will accept or reject in  
1932 payments to it.

1935 **335. Employment Privacy:** We call upon the Texas Legislature to abolish and oppose fingerprinting and  
1936 DNA/blood sample collection as a requirement for licensure renewal except for state public school  
1937 educators, law enforcement, and health care workers.
